Land Use

- A. Bus facility update Kate sent a report: There is no property available in LO for the relocation of bus facility, but they continue to search for land outside the boundaries. The propane buses are quieter and there is no fuel smell. A propane fueling station is being set up at the bus barn. Cheryl has concerns this is too close to school and houses. Another problem is noise from the backing alarms. Drivers are now told to not return between shifts to help alleviate this and also to reduce traffic congestion, plus new routes out of and into our neighborhood should further cut down on congestion.
- B. Pre-application report Sandy reported on Steel Creek Homes app for house on Quarry across from Haggens. They want to build a 13 unit condominium, 4 stories high. They will have to get many variances to be able to do this project. It is not compatible with the rest of the street, but the planner said we should expect the smaller buildings would be redeveloped into larger buildings in the future. [note: They have since rescinded their offer.]

Cindy and Sandy will attend the pre-app meeting on Sept. 10 re MJ Avery's request for a zone change so she can purchase and develop the lot between her property and the Yakima/WEB property.

- A. LGBA Bruce said they have hired a consultant to make assessments regarding the condition of all city schools.
- B. Emergency Preparedness Jim said they are short of funds to buy equipment for two new assistant coordinators.
- C. Friends of E. Waluga Park Will said that ivy has pretty much been removed in the park. There will be an ivy pull at W. Waluga Park on October 24 at 9:30 am.
- D. Traffic Committee Steve was told that regarding Quarry Road, the City does not regulate cut through traffic and suggests it should be removed from our Neighborhood Plan Goals.
- E. Tree Code Adjustment Committee there will be a total of 11 meetings, one Open House, and the target date to present recommendations to Council is June, 2016. Next committee meeting is Sept. 21.
- F. The house at 15112 Quarry Rd. has been purchased and is being remodeled.
