- III. Treasurer's Report: no changes
- **V. Traffic and Police:** WNA letter written to budget review committee urging to fund CIP projects that are unfunded. Galewood, Douglas Way and Oakridge Rd. (leave on the list).

- 45 ft. height limit
- 91 apartments to pencil out
