- A. Sienna Homes, Paul Mayer, permit #499-19-04947-Request to remove a 28"and 24"White Oak and 15", 30", 32" and 36" Doug Fir (6 significant trees). Plans to mitigate with two 2" Dogwoods, two 6 ft Alaskan Cedars and two 6 ft Red Cedars. City approved this application.
- B. City of LO, permit #499-19-05076-Request to remove one 14" and 16" ornamental pear trees to install a stormwater planter ordered by ODOT. This project is expected to cost approximately \$11,000. Two Sweet Bay Magnolias will be the mitigation trees and is expected to survive in the stormwater planter.
