June 14 minutes and treasurer's report approved

- I. Traffic report –Drivers are not slowing to 15 mph at the roundabout.
- II. Traffic goal #3- Cindy received an email reply from Jennie Knapp, principal at LGES saying that the school district is looking at refining the student drop off/pick up for the entire school district this fall. Cindy will contact Stuart Ketzler, School District Finance Director, to discuss changes to the ingress and egress of vehicles entering and leaving the school. She is proposing moving the playground fence along the driveway which then would allow vehicles to exit the school via the driveway while buses are parked. She is also proposing that vehicles exit onto Boones Ferry Rd. at the right and prohibit vehicles to exit the school via Douglas Way
- III. Land Use - Cheryl
 - A. Quarry Commons –Developer decided to retain the original color. We should monitor the parking-on Quarry in front of the development to see if safe passage of vehicles from BFR, Quarry Road, Banner Bank and Albertsons properties is not compromised.
 - B. Trammell Crow is selling the Idaho property and advertising a 45' building could be built on the Hallmark corner.
 - C. Shorenstein has applied to remove 2 trees on their Kruse Way property at 4000 Kruse Way Place.
 - D. ReNew apartments have trees marked to be hopefully only pruned and not removed on Qakridge Road.
- VI. City News and Other Announcements
 - A. Cheryl volunteered and was selected to be on the LO Urban & Community Forestry Plan focus group representing one of 24 recognized LO NA.
 - B. A Neighborhood Chairs Committee (NCC) meeting will be held on Saturday, July 15. Jeff Gudman will be discussing the future of tolling on I-205 & I-5.
