III. LAND USE-Cheryl et al

A. Pre-app follow-up for 3500 Carman Drive, 3 residential lot partition: Civil Engineer is being hired soon according to the developer, Schuyler Smith, Polyphon

B. Mercato Grove request to modify the number of surplus residential spaces is open for public comment (LU-24-0017) until 6/17/24. Modification includes a reduction of residential parking spaces from 286 to 2006.

C. Kruse Oaks "Willow" apartment building: 5600 Meadows Rd: Anticipated move-in: early Fall. <u>https://willowlo.com/</u>

D. 4284 Oakridge Rd property for sale by Home and Garden real estate, \$1.225M, zoned NC/RO (neighborhood commercial/residential high density)A prior development plan has been submitted and gone through the required neighborhood meeting stage. However an application was never submitted by Rob Matthews, Blue Palouse development.

E. Quarry Commons mixed use development (15948 Quarry Rd.) update: Unanswered questions still remain: 1. Are the two ground floor spaces facing Quarry Road short term rental units? Letter of inquiry from the City has been sent to the land owner.2. A large motor home is occasionally parking along Quarry Rd. in front of bldg. A. taking up two spaces. If anyone witnesses this, please call the 911 nonemergency number to report this illegal parking.

F. Lake Grove Elementary School town hall mtg held on Sat. June 8 hosted by LO School Board: Katherine recapped the LO School Board town hall meeting regarding the future plans for use of the Lake Grove Elementary School property. The well-orchestrated and scripted meeting did not provided answers to many of the questions posed from the community. The mtg moderator was Patrick Malee, editior of the LO Review.

- Addition of waste receptacles and/or doggie doo bag dispensers mostly along BFR: Specified locations w/in WNA boundary-**Katherine**
- Repair heaving concrete pathway areas on Quarry Road in front of E. Waluga Park -Linda
- Improve landscaping in the center of Carman/Quarry/Meadows Rd. roundabout-**Katherine**.
- Add a speed bump on Quarry Road in front of Cheryl & Katherine's house-Cheryl
- Add NO PARKING signs on Douglas Way west side from Hallmark Dr. to Quarry Rd-Cindy

- Add NO LEFT TURN warning signs from Douglas Way to BFR and NO LEFT TURN warning from BFR to Douglas Way (traveling N.) and add a crosswalk (location?)-**Rett**
- Add another digital speed feedback sign on Quarry Rd traveling West beyond Country Woods Ct.-Cheryl
- Install crosswalk markings with road sign(s) on Waluga Drive at Oakridge Road-**Mark Exley**
