1. Traffic, Police & Fire Report - Cheryl

- Carman Drive pathway/sidewalk project has been delayed due to it's complexity. Selection of contractor and construction work has been postponed to early-mid 2026.
- Fire LO fire dept. hired a LO senior facility paramedic

2. Land Use: Cheryl

- Cascadia/Hallmark Educational Partners for Goddard school development at 15455
 Hallmark Dr is continuing to try fine tuning the needs of the franchisee, Goddard
 Preschool before submitting their application to the City. Cascadia still plans to remove
 the tall weeds on the property. In addition, the open space easement that serves Mercato
 Grove property will continue to be their responsibility for maintaining the resource
 protected and sensitive lands area.
- 4000 Kruse Way zone change amendment request from OC to R-0 & future redevelopment plans (PA-25-0026) for this 12.7 acre site. Owner and developers are planning to demolish all three existing commercial office buildings and rebuild 350 apartments, 4 stories high and approximately 70-80 townhomes (fourplexes) on this property. The developer has mailed invitations to property owners within a 300 ft radius of the site for a neighborhood meeting.
- 5885 Meadows Rd. pre-app meg. To request pickleball court and amenity structure (PA-25-0030) (LFNA) June 12 via Zoom
- Tree removal Application: 15750Quarry Rd. resubmitted for removal of 44" dbh Douglas Fir only requires mitigation of one tree. Despite the Douglas Fir the dbh.
- 5110 Carman Drive property partition; Meeting notes indicated there were no major issues from the LFNA reps who attended the neighbor meeting. A good neighbor plan was requested and the developer has agreed.

- +Apartment development along BFR built by Mark Fitkin are all rented
- + Steve Kaer has a property that is to be redeveloped, but his application is pending because West Sunset needs to be extended across BFR
- +Chamber's flower baskets are all up now. They cost \$400 each
- +LG wine walk sponsored by the LO Chamber of Commerce resulted in a 30% increase of participants from last year. There were 29 Oregon Wine vendors participating this year.
- Emergency Preparedness: On June 12, 6 Waluga EP coordinators are participating in a team building and neighborhood resiliency training sponsored by the LO Fire dept. On June 17 monthly FRS radio drill is scheduled and on June 19 our monthly EP meeting is scheduled.
